The Purpose of a Court Date

Types of Court Dates

Court dates vary depending on the charge, county, and stage of your case. Here's what you might encounter:

| Court Setting | Purposes | What Usually Happens |

| First Appearance | Confirms charges and sets next court date | Attorney may appear for you; no witnesses or testimony |
| Administrative / Status Date | Updates the court on case progress | Used to negotiate, review discovery, or file motions |
| Trial Date | Case is heard before a judge or jury | Evidence presented; witnesses testify |
| Plea or Disposition Date | Case may resolve through plea or dismissal | Attorney presents agreements to the court |
| Sentencing / Review Date | Determines final punishment or compliance | Often follows plea or conviction |
